Together we will create "necessary" space Because there is no such thing as a "safe space". We exist in the real world. We all carry scars and we have all caused wounds








In the next three years MEA will organize 20% of the current new hires based on the November 2023 number of 22,210.

Figure out how much per person in your local that equals. Ask each member to donate \$5 to \$20 each. Locals that are not attending, but are eligible for a delegate(s), please still do a drive. We will apply it to a delegate in your region. Each local is responsible for raising the full amount for each delegate, even if they are only sending one delegate. (Make sure to record who gave and how much.)





# 3-1(g) COMMITMENT

- 3-1(g) is a NEA Bylaw that states that all affiliates should strive to send the number of delegates to the NEA RA that correlate with the latest census – MEA 30%
- MEA membership nor the education profession does not reflect this number.
- MEA set a growth goal for participation.

#### Reflections

- Many locals who are eligible for 1 or more delegate are not sending delegates or not their full amount
- People of color are not elected in 3–1(g) seats
